Introduction

These Terms of Use govern your use of the Greenbok.net website, its products label database, and any advertising or other services (collectively, the “**Website**”) provided by Greenbook that are not subject to a separate agreement with Greenbook or Agworld, Inc. Greenbook and the Greenbook.net website are wholly owned and operated by Agworld, Inc., and these Terms form a binding agreement between you and Agworld, Inc. (referred to throughout as “**Greenbook**”).
